The City of Cook has received IRRRB funding for \$65,000 and St Louis County CDBG funding for \$60,523 for the 3rd Ave-3rd St. / 1st St. SW / 4th Ave Culvert, Drainage and Paving project for 2012. Administrator – Clerk/Treasurer Martinson is requesting council approval to accept and sign for grant approval.

Motion by Brunner, second by Bixby to accept and sign for grant approval for \$65,000 IRRRB funding and \$60,523 St Louis County CDBG funding for the 3rd Ave-3rd St. / 1st St. SW / 4th Ave Culvert, Drainage and Paving project for 2012. **MOTION CARRIED**

The MN DNR provided information on a Community Tree Survey and grant sources available and this information will be forwarded to the Parks and Beautification Committee for review.

Great River Energy has requested an easement from the City of Cook along Highway 115 for \$5,160. The easement is located on the property purchased from Thomas and LeeAnn Erhbright Trust in Cook, MN. Purpose of easement is to construct, reconstruct, relocate, operate, repair and maintain on the easement area, and in or upon all streets, roads or highways abutting said lands, an electric transmission line or system, consisting of single pole structures and appurtenances, and telecommunications facilities, including fiber optic cable. Attorney Mark Weir has reviewed the easement and recommends the City of Cook enter an agreement with Great River Energy.

Motion by Brunner, second by Storm to approve an easement to Great River Energy from the City of Cook along Highway 115 for \$5160. Easement No#: LC-TC-133A more particularly described as Exhibits A, A2 & B. **MOTION CARRIED**
